Minutes  
May 17, 2011

Meeting called to order by President Kathleen Fauke at 8:07 p.m. Roll call vote showed the following members present: Kathleen Fauke, Denise Haake, Charly Hemker, Darin Johnson, Mark Kohlen and Gail Theising.
